



acd Webinar Frequently Asked Questions

1. What is a webinar?

Webinars are live, online trainings. ACD webinars are interactive and give participants the opportunity to gain new knowledge, discuss the chosen topic, ask questions, and earn free training credit.

2. Who can attend ACD webinars?

Eligible ACD webinar participants include: home child care providers, assistants, center staff, and relative care providers who participate in the Child and Adult Care Food Program with ACD.

3. How much do ACD webinars cost?

ACD webinars are a free benefit to the staff of the child care homes and centers who participate in the Child and Adult Care Food Program with ACD.

4. I have not received confirmation that I registered for the webinar. What should I do?

You will receive a confirmation email when your registration has been processed (within 5 business days). If 5 business days have passed and you have still not received confirmation, email training@acdkids.org.

5. Can multiple people watch the webinar on the same computer or device?

In order to receive a training certificate, webinar participants must register for the webinar individually and attend the webinar on separate computers or devices. Individual registration and attendance is the only reliable way to verify webinar attendance.

6. How do I receive my webinar training certificate?

Webinar training certificates will be emailed to participants within 5 business days of attending the webinar. Please note that the training certificate will be addressed to the name of the registered attendee and cannot be changed. Please register using your own name and email address.

7. Can I watch the webinar later and receive training credit?

Currently the webinars must be watched live to receive training credit. The opportunities to participate, share ideas, and ask questions are a valuable part of attending ACD webinars live.

8. Can I watch the webinar on a device other than a computer?
